### Trust objective

The company was launched in 2021, with an investment objective to deliver an attractive level of capital growth by investing, directly or indirectly, in a diversified portfolio of hydrogen and complementary hydrogen focussed assets whilst integrating core ESG principles into its decision making and ownership process. The Company is an Article 9 climate impact fund under the Sustainable Finance Disclosure Regulation.

### Proposed change of investment policy

The Company is proposing to adopt a managed realisation policy as further described in the [circular to Shareholders](#) published on 29 October 2025, with notice to convene a general meeting of the Company on 1 December 2025 ("GM") to seek shareholder approval for, inter alia, a change of investment policy to that of a realisation strategy. The Directors and the Company's largest shareholder, Ineos Energy intend to vote in favour of the relevant resolutions at the GM.
